Dear Brother and Sister Firefighters and EMTs:

The MCVFA dues year runs from July 1, 2023 through June 30, 2024, so it is **TIME TO RENEW YOUR MEMBERSHIP**. Your Department will be receiving the MCVFA Membership Pack which includes the 2023-2024 Membership dues form and invoice for your records.

The MCVFA is once again **HOLDING DUES AT 2018 LEVELS**, despite double digit inflation over the past five years. It requires your continued support and dues to keep the MCVFA operating at \$20. per member. Please pay dues <u>as soon as possible</u> as it is very hard to keep dues constant if we need to wait for members to pay.

We are refocusing and redoubling our efforts on getting your voices heard. For example:

- Right now, the Commonwealth is choosing a new State Fire Marshal. There is an MCVFA
 representatives on the search committee to bring your voice and needs to the process.
- We also have representation on the Massachusetts Fire Training Council (MFTC), which "is the sole
 certifying agency for certification of all levels of fire service personnel in the Commonwealth" and which
 "promulgate[s] rules and regulations for the operation of the Massachusetts Firefighting Academy and
 has the authority to approve courses and curriculum taught by the Academy." The MFTC <u>supervises the
 training and certification of firefighters</u> in the Commonwealth, so it is essential that the voices of call and
 volunteer firefighters are heard.
- We also send representatives to the National Volunteer Fire Council (NVFC), which represents call, volunteer, and EMS personnel at the national level and helps set national policy.

This representation ensures that **YOUR VOICE** is heard at the State and National level. Beyond this, membership also provides you with a 24/7 Accidental Death and Disability (AD&D) insurance policy, not just when you are "on duty." We also provide education and training through our website and *Smoke Showin'*, which is now online.

We need your help to continue working for you, so please pay your dues today. And we always look forward to your thoughts and ideas in keeping the MCVFA moving forward.
